Personnel & Negotiations – Met on April 18, 2023 - Will be discussed in executive session.

Buildings and Grounds / Finance - Met on April 18, 2023 - The committee met and went through finance stats. Itinerant programming is continuing to grow and Sussex ESC continues to get requests. NHA is losing two students but there are more tours scheduled. Enrollment is holding steady. Over spring break windows were installed, the septic was pumped and mulch was put down. Tick treatment is in the process of getting scheduled.

XI. SUPERINTENDENT'S REPORT

Overall the month of April was about programs. Non Public and Itinerant Programs have been working without a single focal point person for several months. The Administrative Assistants have been working collaboratively with the Superintendent to ensure operations were as normal, but without the hands on specific approach, some areas needed more attention. Non Public annual consultation meetings have occurred in several districts. They will need to be completed in May for all school districts. Itinerant programs are still popular with school districts. Our nursing services contracts have exploded.

Project Search: April was a very busy month for Project Search. Both programs at Hackettstown and Newton were busy with meeting potential students and providing activities for new interns. The interns for the current year are successfully in their 3rd rotation.

Superintendent attended the Abilities of NWNJ Diamond in the Sky Gala supporting Abilities, Project Search and graduate intern Erin Quinn. The evening was a beautiful night honoring Atlantic Health Systems, Project Search and the individual achievement of Erin Quinn.

Northern Hills Academy: The month of April was highlighted by Autism Awareness. All of our students and staff completed multiple activities throughout the month on spreading autism awareness. The Kittatinny High School Student Council came to our Autism Walk on April 28, 2023. Students participated in many activities like face painting, craft making, ice cream sundaes and the walk.
