Northern Hills Academy

On March 13th, our staff members engaged in a professional development presentation led by Cara Faris, one of our student's parents, who presented on American Sign Language (ASL). The session was both informative and interactive, providing our team with the chance to learn a variety of signs that will enhance our communication with students. With Cara's expertise and enthusiasm, our staff left the presentation feeling empowered and excited to incorporate ASL into their daily interactions, fostering a more inclusive and supportive learning environment for all students.

Our school community came together to participate in an Autism Walk, celebrating neurodiversity and fostering awareness and inclusion. This event brought together students, staff, and parents, all of whom took part in the walk, alongside engaging in a variety of crafts and sensory activities designed to be both fun and educational. The event highlighted our commitment to creating an inclusive environment where all individuals are celebrated for their unique abilities. Each year the Autism Walk has become a cherished tradition within the Northern Hills community.
